## About Climate Bridge Fund (CBF)

The Climate Bridge Fund (CBF) is a trust fund established by BRAC with support from the Government of Germany through KfW. CBF supports urban adaptation measures in the context of climate-induced migration.

The Climate Bridge Fund has been set up to "bridge" the financial gap from short-term project funding to sustainable provision of services and infrastructure for climate-induced migrants. The aim is to strengthen the resilience of vulnerable people in urban areas who are either displaced or are at the risk of being displaced due to the impacts of climate change.

#### About the Call

Climate Change implications on migration have been pointed as an emerging risk in the entire world<sup>1</sup>. In Bangladesh, migrants and displaced people in the urban areas are critically exposed to different types of climate change related hazards including rising temperature, drought, heavy rainfall, water logging, flood/flash flood, cyclone and storm surges (particularly in the coastal zone), sea level rise, salinity intrusion and so on. These climatic hazards may result to damage of household properties, contamination of water sources, increase in climate sensitive diseases and loss of livelihoods<sup>2</sup>. The 8<sup>th</sup> Five Year Plan (8FYP) of the Government of Bangladesh clearly recognizes the outmigration patterns from rural to urban areas mainly due to climatic hazards and indicates the needs of putting greater attention to such climate affected communities<sup>3</sup>. The National Adaptation Plan (NAP) of Bangladesh sets "Develop climate-smart cities for improved urban environment and well-being" as one of the six priority national goals. The government prioritizes actions in the cities/towns to enhance resilience of the climate-induced migrants<sup>4</sup>. Partnership with different stakeholders including NGOs, Civil Society Organisations (CSOs), private sectors may need to be increased to ensure

implementation of effective adaptation/resilience measures at the community level in the urban areas as revealed in the above plan.

It is evident that migration inflow in slums would create pressure with additional demand on basic services including access to employment, housing, water supply and sanitation, health, education, drainage and other infrastructure/facilities in all urban centres including Khulna, Barishal, Rajshahi, Satkhira and Sirajganj. Lack of these basic services and exposure to different climatic hazards referred in National Adaptation Plan of Bangladesh, Bangladesh Climate Change Strategy and Action Plan (BCCSAP) 2009, 8<sup>th</sup> Five Year Plan and other climate change related national policy instruments make the life and livelihoods of urban people especially slum dwellers more vulnerable.

The purpose of this Call for Concept Note is to select projects that contribute in strengthening climate resilient services and infrastructure in selected urban areas<sup>5</sup> in Bangladesh. Intergovernmental Panel on Climate Change (IPCC) clearly mentioned that the people of coastal urban areas would face huge loss and damages due to rapid (e.g., flash floods, cyclones and storm surges) and slow onset events (e.g., sea level rise, salinity intrusion in ground and surface water) in not only Bangladesh but across the world. The risks of the slum dwellers who are socially disadvantaged people would further suffer if climate resilient services and infrastructures are not extended effectively or adaptation actions are not taken immediately<sup>6</sup>. In addition to this the negative impact on women and people with disabilities and other more marginalised communities will even be further.

Through this call, the Climate Bridge Fund (CBF) aims to contribute in implementation of some of the key national climate change and development policy instruments including BCCSAP 2009, NAP 2022; 8FYP (2020-2025), Climate Change Gender Action Plan (ccGAP), The Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW, 1979) and Perspective Plan (2021-2041) that critically recognize the need of addressing climate resilience in urban areas through improvement of services and infrastructures. The selected projects would also contribute to implementing the Paris Agreement, Sustainable Development Goals (SDGs) and Sendai Framework for Disaster Risk Reduction in Bangladesh.

Submission of Concept Notes open on **07 November 2023 (Tuesday)** and closes on **24 December 2023 (Sunday)** at 11:59 pm BST.

The total budget available for BRAC through this call is 49.63 million BDT.

#### Focus of the Call

The Climate Bridge Fund (CBF) invites NGOs (registered under NGO Affairs Bureau of the Government of Bangladesh) to submit project ideas using the prescribed Concept Note Template to respond to this call. Under this Call, CBF will support gender-responsive projects that contribute to strengthening the resilience of climate change induced displaced populations (men and especially women, wherever possible with a specific focus on women/ taking the specific needs of women into account), host communities and other vulnerable groups living in slums/informal settlements in selected urban areas of Bangladesh. The following section contains details on who is eligible for CBF funding.

## Eligibility Criteria for accessing Climate Bridge Fund

Interested BRAC Programme(s) need to fulfil the following criteria to be eligible for funding. The Climate Bridge Fund eligibility requirements can be classified as: proposed project ideas (mentioned below as "project-related criteria") and the implementing organisation (mentioned below as "organisation-related criteria"). The proponent should carefully consider whether they fulfil these criteria and have the capacity to offer and implement projects of this nature.

#### Project-related Criteria:

- **Impact:** Proposed project will contribute to the provision of sustainably operated, climate resilient and gender equitable services and/or urban infrastructure in order to strengthen the resilience of vulnerable people impacted by climate change.
- Geography: Proposed project will be located in one or multiple urban slum(s) with a
  high share of climate-induced migrants and be targeted towards low income,
  vulnerable communities, including women and other marginalised communities living
  in the city corporation/municipality areas, where German Official Development
  Cooperation is active: Khulna, Barishal, Rajshahi, Satkhira and Sirajganj.
- Bridge funding: Proposed project should fall in one of these three categories:
  - Continuance and scale up of successful pilot projects to guide these into financial sustainability
  - 2. Innovative ideas that have potential for scaling up and self-sustainability
  - 3. Contribution to longer term operations and maintenance of essential urban infrastructures, that would otherwise remain idle.
- National plans and local planning: Projects need to be consistent with relevant national plans and policies, such as NAP as well as with local plans such as city or town master plans. Additionally, proponents must ensure that the city corporation and/ municipality authorities are supportive of the suggested project by consulting/sharing the proposed project idea with them prior to submission of the concept note.
- **Knowledge generation:** Project contributes to generating knowledge on climate change resilient solutions in urban slums, on a broader scale.







- **Community participation**: Project has to be developed in a participatory manner with the target groups and/or other stakeholders.
- Gender: Project needs to be gender-responsive or gender-transformative. A female
  participation of at least 50% must be supported by specific measures that address the
  needs of women and contribute to the empowerment of women. Wherever possible,
  the projects should also contribute to the transformation of existing gender norms and
  values (gender-transformative projects).
- **Feasibility:** Project should be technically feasible with a timely implementation of the proposed work plan along with a sound methodology.
- **Viability**: Project should be economically viable, especially when falling into category 1 and 2 of bridge funding (such as positive return on investment and financial efficiency ensuring proper value for money).
- **Duration and budget:** Project should have a duration of 3 to 5 years and require a contribution of 5-30 million BDT, i.e., 50 lakh BDT to 3 crore BDT from the Climate Bridge Fund (exceptions can be made given that sufficient justification is provided).
- Environmental & Social Impact: Project should have no significant negative environmental and social impacts. It must also consider how to practically manage any possible risks. Project should not involve any involuntary resettlement.
- **Do no harm concept:** Proposed project does not threaten social cohesion or create/contribute to existing conflict.

#### Organisation-related Criteria:

- Track record: The applicant organisations/BRAC Programme (s) must have prior experience of implementing projects of similar nature. Additional points will be awarded for prior experience of working in proposed locations, however it is not an exclusion criterion.
- **Budget size:** The applicant organisations/BRAC Programme (s) should have the proven capacity to handle a sufficiently large budget. Additionally, they must have experience of implementing at least two foreign funded projects in the past five years, each of which are at least the financial size of the submitted proposal.
- **Implementing capacity:** The applicant organisations/BRAC Programme (s) should have adequate human resources equipped with relevant skillsets, for quality implementation within the proposed timeframe.
- **Financial capacity:** The annual budget of the applicant organisation in each of the last three years should be at least five times higher than the financial size of the submitted proposal.
- **Own contribution:** The applicant organisations/BRAC Programme(s) is willing and able to contribute to co-financing the project (not obligatory but would be appreciated).
- **Fiduciary standards:** The applicant organisations/BRAC Programme(s) are compliant with fiduciary standards typical for international funding.







- **Financial management**: The applicant organisation/BRAC Programme(s) should have a well-established internal control system that is documented and has regularly publishes annually audited financial statements.
- **Compliance:** The applicant organisations should not be:
  - listed on any sanctions list issued by the United Nations Security Council, the European Union, the Federal Republic of Germany or the Government of Bangladesh
  - breaching embargoes regulating foreign trade

## How to Apply

Eligible BRAC programme(s) are requested to complete the Project Concept Note using the approved template available at <a href="www.brac.net/cbf">www.brac.net/cbf</a> and submit to <a href="mailto:cbf.info@brac.net">cbf.info@brac.net</a>.

Interested proponents are requested to take note of the following:

- All parts of the Concept Note template must be properly filled in English in order to be considered eligible.
- As part of the concept note, the applicant BRAC Programme(s) shall also fill out a short checklist on environmental and social impacts, provided as Annex to the Concept Note Template.
- Please watch the <u>video tutorial</u> on concept note development process and contentrelated requirements.
- Please also join the online concept note briefing session to be held on 14 November 2023 (Tuesday) at 3:00 PM following the link: <a href="https://meet.google.com/yvb-fdjb-vnz">https://meet.google.com/yvb-fdjb-vnz</a>.
- In order to promote a healthy competition of ideas, BRAC Programmes are required to submit project concepts summing up to at least twice the total amount of CBF allocation for BRAC in 2023. This should not only be in the form of double the volume but also in absolute number of the projects proposed.
- All BRAC programme(s) interested in submitting a Concept Note under CBF must provide information on their proposed concept and their institutional capacity. The respective BRAC programme(s) with the incorporated feedback and authorised approval from internal designated committee/group(s) (e.g., PCC/other designated body) will prepare the project concept note(s) in the given template in stage 1.
- Interested BRAC programme(s) are to submit the project concept note to CBF Secretariat at cbf.info@brac.net, maintaining necessary internal procedures and approval processes of BRAC, in stage 2.
- In stage 3, the Concept Notes will be reviewed and ranked by the secretariat to proceed to the next stage. CBF secretariat may visit the fields of applicant programme(s) to learn about the programme modalities in details at this stage.







- In stage 4, the shortlisted project ideas are submitted to the Advisory Committee of the Climate Bridge Fund (ACCF). ACCF will review and recommend shortlisted projects to the Trustee Board for final approval.
- Selected BRAC programme(s) will be notified through email and requested to develop detailed project proposals. As part of the detailed proposal development, the applicant programme(s) shall fill out another checklist on environmental, social and gender safeguards related issues especially for proposed infrastructure services.
- After the proposals are evaluated, those are once again shared with ACCF for their recommendations and with KfW for No Objection. It is then finally sent to the Trustee Board for final approval. ACCF/ CBF may request for a presentation directly from the applicant Programme(s) during this stage of evaluation.




Figure 1. Project selection timeline (2023)
